Following submission of the Newark and Sherwood Amended Allocations & Development Management Development Plan Document (DPD), examination hearings were held between Tuesday 5 November and Tuesday 12 November 2025. As part of the examination hearing the Inspector, Mr Hayden Baugh-Jones BA(Hons) DipLA MA CMLI, has identified a number of Main Modifications to rectify issues of legal compliance and/or soundness with the Amended Allocations & Development Management DPD.

The Inspector is now inviting representations on the proposed Main Modifications and will also take into account any comments received in relation to the supporting documents. Any representation made about the proposed Main Modifications should address the effect on the Plan's soundness or legal compliance. The modifications have been put forward without prejudice to the Inspector's final conclusions, and all representations made will be taken into account.

In addition to Main Modifications the Council has proposed a number of Minor Modifications/Points of Clarification, which are not formally part of the Examination process but which we are consulting upon at the same time as seeking representations on Main Modifications.

Please note this consultation is confined to the Modifications (including Main Modifications and Minor Modifications/Points of Clarification) and the other documents mentioned above only. It is not an opportunity to re-state points previously made, to raise new representations to the submitted Amended Allocations & Development Management DPD, or to seek further changes to the DPD. The modifications have been

put forward without prejudice to the Inspector's final conclusions, and all representations made will be taken into account.

In addition to the consultation on these Modifications the Council has produced:

- An assessment of the impact of the Main Modifications on the Integrated Impact Assessment & HRA.

Both of these documents are available to comment on during the period of consultation on the Modifications.
