The Inspector is now inviting representations on the proposed Main Modifications and will take into account any comments in relation to supporting documents.

The District Council is consulting on the following:

- Main Modifications to the Amended Allocations & Development Management DPD
- Minor Modifications/Points of Clarifications to the DPD
- Newark and Sherwood Post Hearing Policies Map Modifications
- An assessment of the impact of the Main Modifications on the Integrated Impact Assessment & Habitat Regulations Assessment.

Background to the Consultation

Following submission of the Newark and Sherwood Amended Allocations & Development Management DPD, examination hearings were held between Tuesday 5 November and Tuesday 12 November 2025. As part of the examination hearing the Inspector, Mr Hayden Baugh-Jones BA(Hons) DipLA MA CMLI, has identified a number of Main Modifications to rectify issues of legal compliance and/or soundness with the Amended Allocations & Development Management DPD.

The Inspector is now inviting representations on the proposed Main Modifications and will also take into account any comments received in relation to the supporting documents. Any representation made about the proposed Main Modifications should address the effect on the Plan's soundness or legal compliance. Representations will be recorded and sent via the Programme Officer to the Inspector for consideration. The Inspector will take into account all the duly made representations received as part of this consultation in reaching his conclusions on the soundness of the DPD and its legal compliance.

Any representation on Main Modifications should consider whether they are legally compliant and sound. These concerns are explained in more detail through this guidance.

In addition to Main Modifications the Council has proposed a number of Minor Modifications/Points of Clarification, which are not formally part of the Examination process but which we are consulting upon through the same process as the Main Modifications. Similarly, we are also consulting on Post Hearing Modifications to the Policies Map.

An assessment of the impact of the Main Modifications on the Integrated Impact Assessment and Habitats Regulations Assessment has been prepared and is also available alongside the Main Modifications.

If you are seeking to make representation on the way in which the Council has prepared the Main Modifications, then this is likely to relate to legal compliance.

If it is the actual content, which you want to make a representation on this is likely to relate to soundness.

Please note this consultation is confined to the Modifications (including Main Modifications and Minor Modifications/Points of Clarification) and the other documents mentioned above only. It is not an opportunity to re-state points previously made, to raise new representations to the submitted Amended Allocations & Development Management DPD, or to seek further changes to the DPD.

Closing Date for Representations

Your representations need to be made in writing (either electronically by email or by post) and must be received by the Council by **5pm on Tuesday 28 October 2025.** The Council will not be able to accept comments that are received after the deadline and anonymous responses cannot be accepted.

How to Complete the Representation Form

It is advisable to read the Modifications (including Minor Modifications/Points of Clarification) and assessment of the impact of the Main Modifications on the Integrated Impact Assessment and Habitats Regulations Assessment and the Modification of the Policies Map in conjunction with the Submission Amended Allocations & Development Management DPD (CD01b - Submission Version AADMDPD (Clean Version)) before representations are submitted to ensure the relevance of each representation.

Part A- Personal/Agent Details

You must complete all your contact details. This is used to identify who has made the comments(s), so it is important you complete this fully.

The first list of boxes relate to representations from individuals. The second list of boxes should be completed if an agent is being used (if relevant)

Part B – Main Modifications Representation Form

This is where you need to make your comments on the legal compliance or soundness of the Main Modifications

If you wish to comment on more than one modification, please complete a separate Part B sheet for each modification.

Name and Organisation

Please include your name/organisation at the top of each 'Part B' form that you use so that it can be linked to Part A of the representation.

Question 1

Please state to which Main Modification your representation relates to.

Questions 2, 3, 3a, 4

Please provide your comments and state whether they relate to legal compliance or soundness and your reasons for this.

(i) Legal Compliance

The Inspector will first check the document meets the legal requirements required under the Planning and Compulsory Purchase 2004 and Localism Act 2011, before moving on to the tests for soundness.

(ii) Soundness

This means that the Inspector has to be satisfied that the DPD is positively prepared, justified, effective and consistent with national policy. If you wish to make comment on more than one of the four matters of soundness in relation to a specific modification, please complete a separate Part B sheet for each matter of soundness. You should consider the following before making a representation on soundness:-

Positively prepared –the DPD should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development;

This means that the Plan meets the objectively assessed the need for housing, employment, services and infrastructure in Newark and Sherwood as set out in the Amended Core Strategy and that they will be delivered sustainably. If you think that the DPD does not do that, then your comments will relate to whether the DPD has been positively prepared.

Justified - the DPD should be an appropriate strategy, taking into account reasonable alternatives, based on proportionate evidence;

This means that the DPD has a robust and reliable evidence base to justify the chosen options. If you think that the evidence does not make the choice in the DPD appropriate, then your comments will relate to whether the DPD is justified.

Effective – the DPD should be deliverable over its period and based on effective joint working on cross boundary strategic priorities;

This means that the DPD will deliver what it sets out to. If you think that the proposals in the DPD will not happen due to deliverability issues, or they do not join up with the strategies of neighbouring authorities, then your comments will relate to whether the DPD is effective.

Consistent with national policy – the DPD should enable the delivery of sustainable development in accordance with the policies in the Framework and other statements of national planning policy.

This means that the DPD accords with national planning policy, or includes clear and convincing reasons when it does not. If you think that the plan conflicts with national policy, then your comments will relate to whether the DPD is consistent with national policy.

If you wish to make a representation seeking a change to a Main Modification or Minor Modification/ Point of Clarification you should make it clear in what way it is not sound, having regard to the four tests as set out above.
