**0577 Apologies**

No apologies were received.

0582 **Correspondence/Information**

The following items of correspondence/information were noted:

- a) Notice that the District Council Enforcement Department is scheduled to issue a Breach of Condition Notice on the owner of the Gypsy Caravan site on Main Street.
- b) The appeal for 322 residential units to be built on the former Flowserve site off Hawton Lane has been successful. It is understood that the Planning Inspectorate permission has granted permission without a Section 106 agreement and is not subject to a Community Infrastructure Levy fund. Members were shocked to hear this and asked that a letter be sent to local M.P. Robert Jenrick questioning how this could be allowed. Clarification will also be sought as to what the current District Council policy is regarding the ratio of affordable housing on new developments as there are none on this scheme. Details regarding diversion of the Sodbridge Drain which runs through the site are still awaited; these will again be expedited. It is understood that the necessary upgrading/expansion of Balderton's sewage works has still been undertaken; enquiries will be made with Severn Trent to ascertain when this will take place.

The meeting was closed at approximately 2.45pm
