- (a) For Noting - 22/01621/TPO – Parish Church of All Saints, Cotham Lane, Hawton - T1 through T15: 11x Lime trees, 2x Beech trees & 2x Sycamore: Remove epicormic growth around the stems to a height of 4m. Crown raise the lower branches to give 5.2m clearance over the drive and prune back branches to clear the cables by 2m. Remove major deadwood from the canopy. T16: Large Beech tree: Crown reduction in height by no more than 3m and lateral branches by 2m. Branches pruned back to the nearest suitable replacement union to maintain a natural flowing branch line and canopy shape.
- (b) 22/01449/FUL – Barns at Willow Farm, Newark Road, Hawton - Change of use of Barns from storage to holiday accommodation and garaging with associated alterations.
- (c) For noting - Staple Quarry, Grange Lane, Cotham - Amendment to planning permission 3/16/00693/CMW to alter the approved restoration and afteruse of the site from agriculture to an ecological / habitat based restoration and afteruse (nature conservation), facilitated through the importation of soil improvement materials to mix with the site's existing soils - variation of conditions 1 (permission reference to agriculture), 22 (restoration and aftercare scheme), 26 (soil replacement - reference to agricultural operations) and 27 (stone removal - reference to agricultural operations)
- (d) Decision Notice - 22/01363/AGR – Willow Farm, Newark Road, Hawton - General-purpose agricultural storage building
